Any person holding the scheduled tribe certificate from the competent authority may person desirous to avail the benefits or concessions available to scheduled tribes i.e. 1. Admission to any educational institution after Standard 10, 2. Government Jobs (Public Employment), 3. contesting elections, shall make an application to the concerned scrutiny committee for the verification of such certificate and to obtain the validity certificate.
